**Re: 2nd NOTICE - Second Consecutive Payment Being Held for Municipal Non-Compliance
under the Canada Community-Building Fund**

Municipalities must fulfill a number of significant terms and conditions (T&C) as outlined in their Municipal Funding Agreement (Agreement). In accordance with the Canada Community-Building Fund's Municipal Compliance Strategy (Strategy), failure to do so can result in a municipality's payment being withheld until compliant.

The ministry has implemented a two-step process where funds are first placed on hold and, after four consecutive payments have been held for non-compliance with any terms and conditions, the municipality will forfeit withheld allocations and may be required to repay some funds. Further information on the Strategy is available on our [website](#).

Your municipality was sent the first notice dated 27-Jan-25, notifying you of the T&C that were outstanding and required to be met to be considered compliant.

To date, your municipality has not complied with the following T&C:

- Submission of 2023 Financial Statement

Failure to address the T&C listed above puts your municipality in default of the Agreement. As a result, your municipality's payments will remain on hold until full compliance with identified T&C are met.

The required information must be submitted by **August 29, 2025**, to bring your municipality into compliance and ensure your municipality receives its 2025-26 Installment 1 payment scheduled for September 2025.

If your municipality remains non-compliant in January 2026, we will send you the Third Notice advising of a date in February 2026 that your municipality must become compliant or have your March 2026 payment withheld.
